On 02/16/2018, at approximately 1512 hours, while working uniformed patrol in a fully marked Seattle Police vehicle as unit 2-GEORGE-2, I was dispatched to Garfield High School located at 400 23 Av, to investigate threats that were made from a student to shoot students. MDT call notes read as follows: "2ND HAND FROM ANOTHER STUDENT, SUSP TOLD SUBJ HE PLANS TO PULL THE FIRE ALARM AND SHOOT AND SHOOT STUDENTS, OCCURRED 2 WEEKS AGO, SUSP POSTED DISTURBING POST ON FACEBOOK TODAY, COMPL REQ OFFICERS CHECK SUSPS ADDRESS/SUSP DIDNT ATTEND SCHOOL TODAY".

I arrived at the dispatched address where officers and I contacted Garfield High School staff. We were escorted to a conference room, where VICTIM/ COMPLAINANT/ COMPLAINANT/ COMPLAINANT/ COMPLAINANT/ Complexity were seated. statements about shooting the school. Stated he would pull the school's fire alarm, and wait for the students to exit the building; once the students made their way out to the field behind the school, he would begin shooting students.

stated attempted to down play the statements, by saying he was simply joking. Informed the statements made were not funny, and he was afraid. Stated other student who witnessed this, also believed stated other student and informed the statements informed would be at the top of the kill list. Stated "at the time I took it lightly, but deep down I was very scared".

and that he feared **control** would follow through with his threats. **Control** stated **control** her.

No documentation of this incident was reported by **Carbo**. Aside from informing **Carbo** did not report this to any other Garfield High School staff.

Snapchat. Stated States later advised several students and him, to add him on Snapchat. States 's reason for this, was to warn them before he followed through with his plan to shoot the school.

informed me, that even though they were not close friends, he and interacted during fifth period. Both sat close to each other near the back of the classroom. However, informed me that after he confronted regarding the threats made, if the classroom, then slowly began to miss classes. If not set near the front of the classroom, then slowly began to miss stated he did not see at school today, but a friend of his did.

At one point during the recorded interview, I observed **and the set up**, in fear of what **the set up** was capable of doing.

I then interviewed **1000**, who at the time was working as a school counselor. **Constraints** informed me she has been counseling **1000**, for several years, because he has been having a difficult time at home and school. Refer to SPD case #17-143901 for previous domestic violence incident. **1000** began to have difficulty focusing at school, his school grades deteriorated, he was unable to engage in classes. **1000** advised **1000** to seek professional counseling, but she is unaware if **1000** did receive counseling. **1000** described **1000** as "a nice kid that is just suffering".

While I interviewed we were informed by vice principal that that submitted a letter of resignation. Stated the letter was submitted on 02/16/2018, which took by surprise.

Sgt. Traver who was on scene, screened this incident with Sgt. Worstman in Homicide and Lt. Ballingham in Intel.

Once the investigation was completed at Garfield High School, officers and I contacted the at his residence. A superior answered the door and appeared to be surprised to see officers at his door. If the identified himself, by name. Was placed under arrest, at this time, he apologized for having made threatening comments to his classmates. A stated he was not serious about the threats made.

En route to East Precinct, **Martine** was advised Miranda Rights along with Juvenile Warnings, from department issued Miranda card.
